1. **Tuesday, 9-20-22 Hospitality Bar** for arriving clerks  
There is no “bar” in the lodge, only a small winery. A bar can be set up in a meeting room.
2. **Wednesday, 9-21-22:**
  - a. **Grafton River Boat Cruise** 9-11 AM; limited to first 49 people; clerks and sponsoring vendors take priority.
    - i. \$27/person with 30-person minimum = \$810
    - ii. \$27/person with 49-person maximum = \$1,323
