Minutes March 8, 2017

Motion to Approve of January meeting minutes was made by Lynden and 2nd by Delbert. Motion passed.

Old Business:

ISSI progress:

Paul has submitted a grant application to STARRS for the ISSI Project at the total cost of \$496,901.00:

Equipment cost includes ISSI license for SLATER system and MOSWIN system, Motorola implementation and 30 software upgrades for IL radios XTL/XTS for testing.

Ryan mentioned that if the ISSI goes through then all departments that would use the ISSI would need to have a radio upgrade which is \$120 per radio. We will be able to install the upgrade so that cost is saving \$80 labor cost per radio.

UPS Batteries: They were replaced on 12-1-2016 at the Sheriffs Office. They have ordered and arrived for Columbia PD and

one is in place, waiting for city to help install the other unit which is scheduled for 3-10-2017. Chief Jerry Paul stated that they had a power outage during the last storms on Monday night and the batteries that have been replaced kept things running.

New Business:

800 Repeater-Waiting on frequencies from FCC, Les has gotten back with us and he is working on getting those.

There was some discussion on where this will be placed and it was talked about still using Brinkmann Farms to flood the 156 hill due to the ISSI hopefully covering everything else. Lynden brought up a possible location at Niebruegge Farms which would be further West than Harrisonville pumphouse if the ISSI don't come through.

Radio Programming- St. Clair County has a new license for their SOA talkgroups which we use. Ours will need to be reprogrammed to be able to communicate with them on SOA talkgroups this will be done as soon as we get notification on when they will be doing theirs which should be soon.

There was some discussion on the cost of the new radios. Ryan mentioned that Waterloo just purchased APX 4000 portables which are \$3,694.50 and APX 4500 mobiles which are \$4,191.50. There was some discussion on the APX 7000 and APX 7500 with the dual band.
