Regional Office of Education Superintendent Kelton Davis came before the Board to make a request for COVID funding. The funds will be used to implement COVID testing in schools located in Monroe and Randolph Counties. Kelton Davis provided a breakdown of estimated expenses and asked Monroe

County to allocate \$70,016 towards the testing program. Commissioner Knobloch made a motion to approve the funding request. Second by Commissioner Green. All voting Aye. None Nay. None Absent. Motion carried.

Edie Koch came before the Board to conduct a CDBG closeout hearing regarding Route 3 Bar and Grill, LLC. The hearing was called to order at approximately 8:50 A.M. by the Chair of the Monroe County Board of Commissioners, Vicki Koerber. Chairperson Koerber proceeded to ask Edie Koch, Executive Director Monroe County EDC, to proceed with the public hearing for the closeout of Community Development Block Grant (CDBG) Grant #13-244390. Ms. Koch first asked that all attendees sign an attendance sheet being circulated. Koch explained that the opportunity for resident participation is a federal requirement for CDBG grants such as the Downstate Small Business Stabilization program.

Next, Edie Koch provided information that the Republic-Times published a notice of this morning's close-out public hearing on August 25, 2021. In that notice, interested citizens were informed how to gain access to all project information connected with Grant # 13-244390 and invited to provide comments or a written statement. As of this date, Koch stated that there have been no comments received for placement in the official record of the public hearing proceedings today.

Ms. Koch went on to explain that the purpose of today's hearing was to report outcomes and provide an opportunity for interested parties to express their view on the program activities and performance of CDBG Downstate Small Business Stabilization (DSBS) grant #13-244390.

The Public hearing attendees were then given background on the grant and details of respective program outcomes that justify closing this grant as follows:

- In response to impacts of COVID-19 to businesses, ILDCEO repurposed \$20 million in Federal CDBG funds to stand up the Downstate Small Business Stabilization Program. This Fund offered small businesses of up to 50 employees the opportunity to partner with their local governments to obtain grants of up to \$25,000 in working capital.
- In May of 2020, the Board approved CDBG DSBS applications for Monroe County for submission to ILDCEO to help cover working capital needs of businesses economically impacted by COVID-19. After an appeal process, in January of 2021, the County received a notice of award from ILDCEO on behalf of Route 3 Bar and Grill LLC in the amount of \$24,800.
- After this Public Hearing, the County will be submitting closure documents for grant # 13-2424390 as Monroe County and Route 3 Bar and Grill have met all performance requirements of the grant as follows:
  - Expenditure of grant is complete and there is a zero balance. On July 6, 2021, Monroe County issued a check to Route 3 Bar and Grill for \$24,800 to cover paid eligible working capital expenses incurred after March 20, 2020, the date of the Governor's Executive Order.
  - Route 3 Bar and Grill has remained open for the required 60 days following the receipt of funds and continues to thrive.
  - Project did not result in the displacement of any persons or businesses.
