Sheriff Rohlfig and Bruce DeLashmit with Bellwether Management Services came before the Board to discuss the results of a fee study for the jail and animal control. Right now, the county receives \$19,907 in fee income for animal control and is supplementing the remaining \$51,964 from general property tax revenue. No action was taken on adoption of new fees. Further discussions with the municipalities regarding this matter will be made by Chairman Knobloch and Sheriff Rohlfig.
