Commissioner Green made a motion to reappoint Randy Rusteberg, Michael Fausz and Leland Mueller to the Maeystown Fire Protection District for a term to commence on May 1, 2022 and expire on April 30, 2025 or until a successor has been appointed and has qualified. Second by Chairman Knobloch. All voting Aye. None Nay. Commissioner Koerber Absent. Motion carried. Resolution #22-35

Commissioner Green made a motion to approve an application for use of courthouse courtyard and bandstand by the Monroe County Arts Alliance for their 1<sup>st</sup> Annual "Chalk-A-Lot" on September 10, 2022. Second by Chairman Knobloch. All voting Aye. None Nay. Commissioner Koerber Absent. Motion carried.

Chairman Knobloch announced that he recently attended a press conference where they announced that the entire area included in the Southwestern Illinois Flood Prevention District has now been accredited by FEMA. They intend to continue collecting the sales tax and would like to bump it up from a 100-year accreditation to a 500-year accreditation.

Kelton Davis came before the Board to request consideration to pass a resolution allowing him to hire an additional Assistant Regional Superintendent, at a salary of 75% of that of the Regional Superintendent. The benefit for us is the funding does not come directly out of the County, it is dispersed throughout the

State, through the Corporate Personal Property Replacement Tax. If the State will not fund this, Kelton will not hire another person. Lucas explained the Board cannot decide to pass a resolution without looking into the matter first. He will do the research and once he's formed his legal opinion, the Board will have a special session to vote on the matter.

Chairman Knobloch stated we have a request from Howard Heavner, Mayor of the Village of Valmeyer, concerning the Rock City TIF District, which is nearing it's 23-year end-of-life, which was started in September 2000 and will expire in September 2023. The only way to extend a TIF District by any time period is by approval of all of the taxing districts involved, followed by approval of the State Legislature. The Village has started that process and is now making contact with Monroe County as Monroe County would normally get a portion of the real estate tax from that area. The property is still owned by the Village of Valmeyer and they are asking that the taxing districts approve a 12-year extension. In exchange for the extension, the Village is proposing to take the amount of money being paid into taxes to first start a maintenance account with the first 5%, then take the next 95% and split it in half – half to the developer, half goes to the various taxing districts, none of whom have been receiving any funds up to this point.

Chairman Knobloch is removing himself from the voting process as a result of his affiliation with Valmeyer. Therefore, this issue will be tabled until the next Board meeting, when Commissioner Koerber will be present to vote as well as Commissioner Green.

There being no further business to come before the Board, a motion was made by Commissioner Green to adjourn. Second by Chairman Knobloch. All voting Aye. None Nay. Commissioner Koerber Absent. Motion carried.
