MINUTES OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS
OF MONROE COUNTY, ILLINOIS JUNE 21, 2021

The meeting of the County Commissioners of Monroe County, Illinois was called to order at 8:15am by Chairman Vicki Koerber.

The meeting opened with the Pledge of Allegiance.

Chairman Vicki Koerber, Commissioner Dennis Knobloch and Commissioner George Green were present.

Others present were Sheila Wetzler, Alan Dooley of the Republic Times, State's Attorney Lucas Liefer, County Clerk Jonathan McLean, and Jason Jones.

Chairman Vicki Koerber asked for public comments. Brian Mehrtens, with the Columbia Levee District, addressed the Board to request funding for levee improvements. He said that he needs to have 137 wells inspected, test and clean the control banks for the pump station, purchase a new two stage air compressor, and perform four or five small slip line projects. Chairman Koerber asked Mr. Mehrtens to submit a proposal and the Board will take his request under advisement.
